

# TERMS OF REFERENCE (TOR) FOR DEVELOPMENT OF TCRS STRATEGIC PLAN

#### 2025-2029

## 1. Background

Tanganyika Christian Refugee Service (TCRS) has been a pivotal organization in providing humaritarian relief and fostering sustainable development in Tanzania for 60 years. With the current strategic plan concluding in 2024, TCRS aims to develop a new five-year strategic plan (2025-2029) that aligns with evolving national and global development agendas, enhances resilience and self-reliance for vulnerable communities, and leverages TCRS's strengths in humanitarian, empowerment and advocacy work.

### 2. Purpose of the Consultancy

The consultant will lead the development of a comprehensive strategic plan that builds on lessons from the 2020-2024 strategy, aligns with TCRS's, vision, mission, values, and objectives, and incorporates insights from relevant stakeholders. The strategy will include:

- a) **Programme Strategy**: Articulating TCRS's thematic focus areas, geographic priorities, and programmatic goals.
- b) **Operational Roadmap**: Identifying the operational and capacity-building needs to support programmatic objectives.

#### 3. Scope of Work

The scope of the consultancy includes:

- a) Conduct a situational analysis covering policy, socio-economic, and environmental trends impacting TCRS's work.
- b) Facilitate consultations with key stakeholders, including TCRS Board of Trustees, staff, partners, government agencies, and beneficiaries.
- c) Formulate goal, objectives and a Theory of Change (ToC) model for TCRS's strategic framework that aligns with long-term goals.
- d) Formulate end and intermediary Outcomes
- e) Draft the Programme Strategy (12-15 pages), detailing:
  - Priority themes (e.g., Emergency support, DRR, Livelihoods, WASH).
  - Programmatic approaches and geographic focus.
  - Integration of cross-cutting issues (e.g., gender, environmental sustainability).
  - Result frame work



- Monitoring and evaluation for accountability and learning (MEAL)
- f) Create an Operational Roadmap with clear milestones for:
- Organizational capacity and staffing requirements.
  - Risk analysis and management strategies.
  - Financial planning to fund the strategy.
  - Increase funding base by adapting new investment opportunities

#### 4. Deliverables

The consultant will be expected to deliver the following:

- a) Situational Analysis and Stakeholder Engagement Report.
- b) Draft Strategy Document.
- c) Draft Operational Roadmap.
- d) Finalized TCRS Strategic Plan 2025-2029.
- e) Donor-friendly summary.

## 5. Methodology

#### a. Preparation and Analysis

- Review TCRS's current strategic plan, internal reports, and the Endline 2020-2024 Strategy report.
- Conduct interviews, focus groups and workshop for a comprehensive stakeholder engagement.

### b. Drafting

- Produce drafts for the Strategy and Operational Roadmap.
- Integrate findings from stakeholder consultations and situational analysis.

#### c. Review and Finalization

- Present drafts to TCRS leadership for feedback.
- Finalize the strategy and provide a donor-friendly summary.

#### 6. Timeline

• The consultancy will commence in mid-November 2024, with the final deliverables due February 28<sup>th</sup> 2025.



#### 7. Selection criteria for consultant

The consultant should have:

- a) Proven experience in strategic planning for humanitarian or development organizations.
- b) Expertise in developing Theory of Change models and programmatic strategies.
- c) Knowledge of Tanzania's development context and TCRS's thematic areas.
- d) Strong facilitation skills for stakeholder engagement.
- **8. Reporting:** The consultant will report to the TCRS Director and work closely with designated TCRS staff.
- **9. Budget:** The budget will cover consultancy fees, travel, stakeholder engagement sessions, and reporting expenses.
- **10.** Submission of details

Interested consultants are requested to submit:

- Academic qualifications
- Relevant services undertaken in the past three (3) years
- Proposed methodology
- Proposed work plan
- Report outline
- Evaluation of team composition and task assignment/roles
- Registration and other relevant statutory documents.
- A detailed Financial proposal.
- A CV and evidence of past experience in similar assignments.
- At least two references from recently clients.



### 11. Deadline

Applications should be submitted by Friday 22<sup>nd</sup> November 2024. Only shortlisted candidates will be contacted for further discussions.
